HOUSE BILL NO. 340

BY REPRESENTATIVE HENRY

Prefiled pursuant to Article III, Section 2(A)(4)(b)(i) of the Constitution of Louisiana.

RELIGIOUS ORGANIZATIONS: (Constitutional Amendment) Provides relative to the freedom of religion

1 A JOINT RESOLUTION

2 Proposing to amend Article I, Section 8 of the Constitution of Louisiana, relative to freedom  
3 of religion; to prohibit government infringement of the right of every person to freely  
4 express his religious belief; to provide that the right shall not be burdened without  
5 the showing of a compelling governmental interest; to provide for submission of the  
6 proposed amendment to the electors; and to provide for related matters.

7 Section 1. Be it resolved by the Legislature of Louisiana, two-thirds of the members  
8 elected to each house concurring, that there shall be submitted to the electors of the state of  
9 Louisiana, for their approval or rejection in the manner provided by law, a proposal to  
10 amend Article I, Section 8 of the Constitution of Louisiana, to read as follows:

11 §8. Freedom of Religion

12 Section 8. No law shall be enacted respecting an establishment of religion  
13 or prohibiting the free exercise thereof. The free exercise of religion includes the  
14 right of every person to freely express his sincerely held religious belief and to  
15 engage in or refrain from activity based on a sincerely held religious belief. Such  
16 right shall not be burdened unless the government proves that it has a compelling  
17 governmental interest in infringing the specific expression, act, or refusal to act at  
18 issue, and that there is no other less burdensome alternative. This burden includes,  
19 but is not limited to direct burdens as well as indirect burdens such as withholding  
20 benefits, assessing penalties, or exclusion from professions, programs, or facilities.

1 Section 2. Be it further resolved that this proposed amendment shall be submitted  
2 to the electors of the state of Louisiana at the statewide election to be held on November 2,  
3 2010.

4 Section 3. Be it further resolved that on the official ballot to be used at said election  
5 there shall be printed a proposition, upon which the electors of the state shall be permitted  
6 to vote FOR or AGAINST, to amend the Constitution of Louisiana, which proposition shall  
7 read as follows:

8 To prohibit government infringement of the right of every person to freely  
9 express his sincerely held religious belief without the showing of a  
10 compelling governmental interest in infringing the specific expression, act,  
11 or refusal to act. (Amends Article I, Section 8)

**Abstract:** Prohibits government infringement of the right of every person to freely express his religious belief without the showing of a compelling governmental interest.

Present constitution provides that no law shall be enacted respecting an establishment of religion or prohibiting the free exercise thereof.

Proposed constitution provides that the free exercise of religion includes the right of every person to freely express his sincerely held religious belief and to engage in or refrain from activity based on a sincerely held religious belief.

Proposed constitution provides that freedom of religion shall not be burdened unless the government proves that it has a compelling governmental interest in infringing the specific expression, act, or refusal to act, and that there is no other less burdensome alternative.

Proposed constitution provides that a burden includes direct burdens as well as indirect burdens such as withholding benefits, assessing penalties, or exclusion from professions, programs, or facilities.

Provides for submission of the proposed amendment to the voters at the statewide election to be held Nov. 2, 2010.
